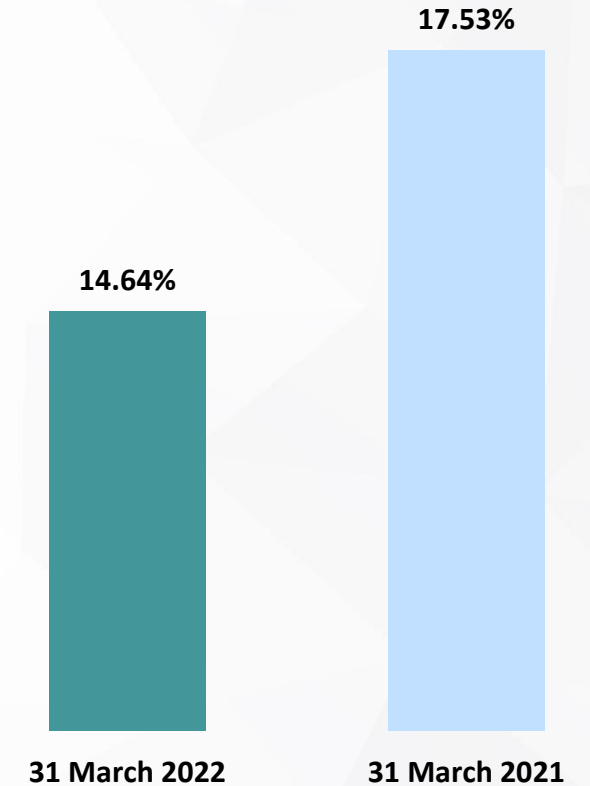

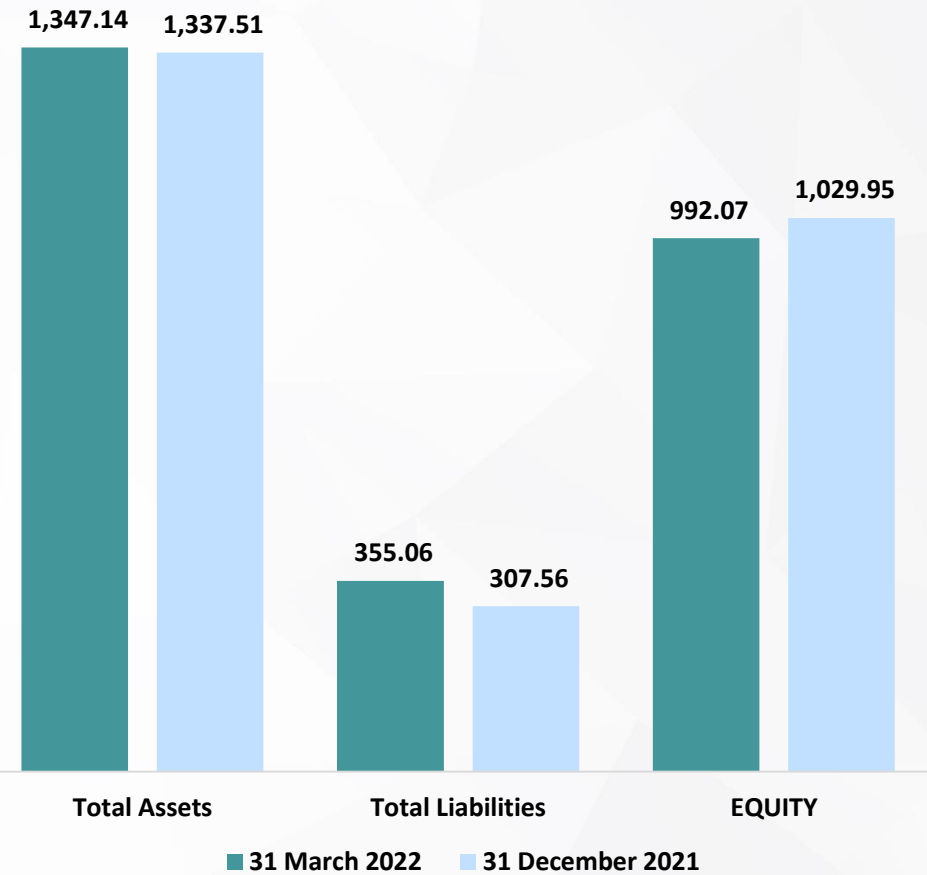
Net Profit Margin
